Throughout his distinguished career, Bill White has focused on results over rhetoric, and common sense solutions over ideology. As former mayor of Houston, the fourth largest city in the country, he earned national praise and the 2007 John F. Kennedy Profile in Courage Award for his swift action after Hurricane Katrina. Within days of the levees breaking in New Orleans, Mayor White responded by opening Houston to evacuees and offering assistance with housing, health care, and employment.

During his tenure, Mayor White tackled Houston's traffic by mandating the quick removal of cars due to accidents or abandonment and revamping signal coordination along major corridors. He also improved Houston's emissions and air quality regulations by negotiating directly with the Houston petrochemical industry. Bill White exemplifies the servant leader, working across sectors and political lines to make a real impact on people's lives.




