## Immigrants Drive the DALLAS ECONOMY

allas is home to over 850,000 immigrants (19.3 percent of the metro population). The immigrant population in Dallas represents close to 20 percent of the entire immigrant population in the state of Texas.<sup>1</sup>

Immigrants have played a leading role in Dallas' economic success and make up 25.2 percent of the total metro division labor force. Dallas immigrants work in a wide range of jobs, most heavily concentrated in construction.<sup>2</sup>


Immigrants also power the Dallas economy as job creators, small business owners and entrepreneurs. Immigrants make up 19.6 percent of business owners with paid employees in the Dallas-Fort Worth-Arlington Metro Area,<sup>3</sup> and are self-employed at a higher rate in Dallas (8 percent) than the Native-born population (5.6 percent).<sup>4</sup>

\*This fact sheet refers to Texas immigrants as any foreign-born resident regardless of immigration or U.S. citizenship status.

Dallas data in this report is for the Dallas-Plano-Irving, TX Metro Division.


#### Where Dallas Immigrants Work
